## Shortcodes

---

This template is made of a base template and a shortcode, `{{< cv type file >}}`.

- `type`: points to one of the supported shortcode types below
- `file`: points to a file with a field with the same title as `type`

This allows you to get the full benefits from Quarto, while having sensible formatting options. Notably, these fill from a `yaml` file (or a series of them).

The supported shortcodes types are:

- `appointments`: for academic appointment information (example file: `education.yaml` under `appointments`)
- `education`: for education history (example file: `education.yaml` under `education`)
- `positions`: for other positions or services (example file: `positions.yaml`)
- `honors`: for listing honors (example file: `honors.yaml`)

Note that all of these will fill in based on the order in the `YAML`. I recommend listing them in reverse order and potentially moving any lifetime awards to the top.

## Listing references

---

This template ships with an adjusted version of `chicago-author-date.csl`, as `nosort-chicago-author-date.csl`. The two differences here are that it doesn't sort, so whatever order is in your `.bib` file is the order that the references will be displayed. Second, it does not replace authors with `---` when you coauthor with the same group repeatedly. As there

is no sorting, this looks funny if you have a random case of this, compared to a normal bibliography. If your `.bib` is messy, use `revsort-chicago-author-date.csl` instead, which reverse sorts by year.

To include a reference, I currently use the `pandoc-ext/multibib` extension. When Quarto updates to use Typst 0.13.0 in version 1.7, this will no longer be necessary.

The current format thus looks like:

1. Add the following to the YAML:

```
bibliography:  
  books: "books.bib"  
  bookchapters: "book_chapters.bib"  
  articles: "journal_articles.bib"
```

2. Include a ref div where you want to insert the references:

```
:::{#refs-KEY}  
:::
```

where `key` is one of the keys in your YAML (e.g., `book`, `bookchapters`, or `articles`).

This is totally open and you could include things like “Working Papers” with their own `bib` file.

The key limitation (currently) is that you require a different `.bib` file for each of your types of citation listings.

### Tables

## Raw Typst

Typst is much easier to learn than LaTeX in my opinion. If you want to add some custom features, you can do that with raw Typst chunks.

For example, suppose that this is a fake CV for a famed, but deceased, member of the Harvard faculty. You might want to add a quote from the NYT obit:

Sidney Verba, whose pioneering research comparing political behavior among the world's democracies became a classic book among students of politics, died on March 4 at his home in Cambridge, Mass. He was 86.
